# Q1 2024 FINANCIAL RESULTS HIGHLIGHTS

Q1 2024 Revenue was \$1.54 billion compared to \$1.17 billion in Q1 2023

Gross Profit percentage increased to 19.3% vs. 17.5% in Q1 2023

SG&A increased to \$162.7 million from \$135.0 million in Q1 2023

EPS was \$2.69 per diluted share compared to \$1.59 (\$1.51 per diluted share excluding an \$0.08 benefit related to tax gains) in Q1 2023

Q1 2024 Cash Flow from Operations was \$146.6 million compared to \$126.9 million in Q1 2023

Q1 2024 Backlog was \$5.91 billion compared to \$5.16 billion in Q4 2023 and \$4.44 billion in Q1 2023



# ACCELERATED CASH


(\$ Millions)

- Pre-bookings and equipment advances will normalize creating cash flow headwind when project costs are incurred


# BACKLOG

(\$ Millions) (Unaudited)




# REVENUE BY TYPE OF CUSTOMER

(YTD)




# REVENUE BY ACTIVITY TYPE
