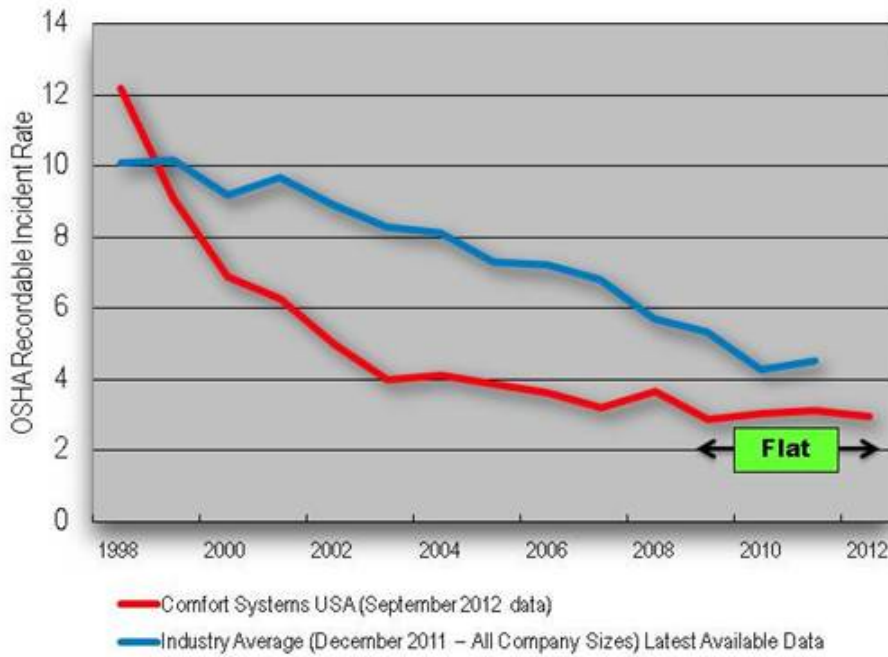

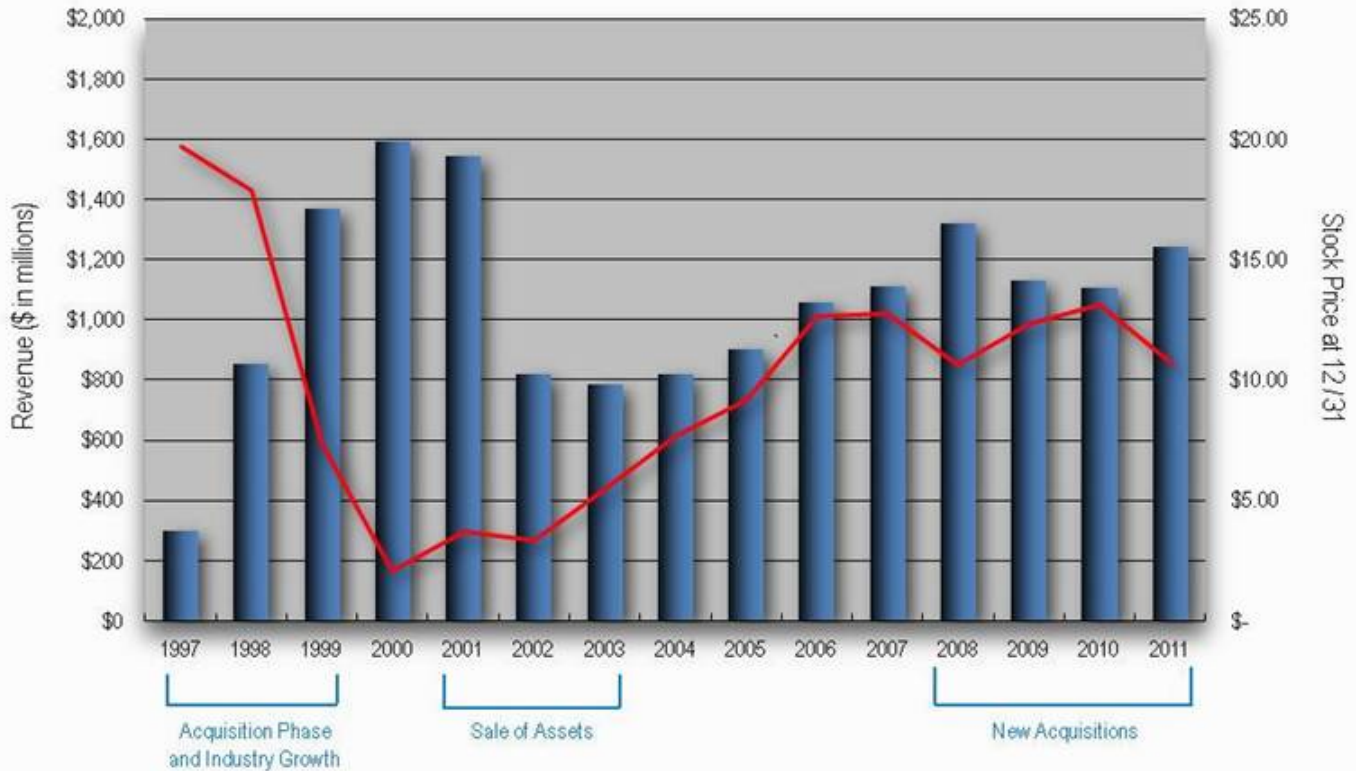

Revenue/Stock Price History



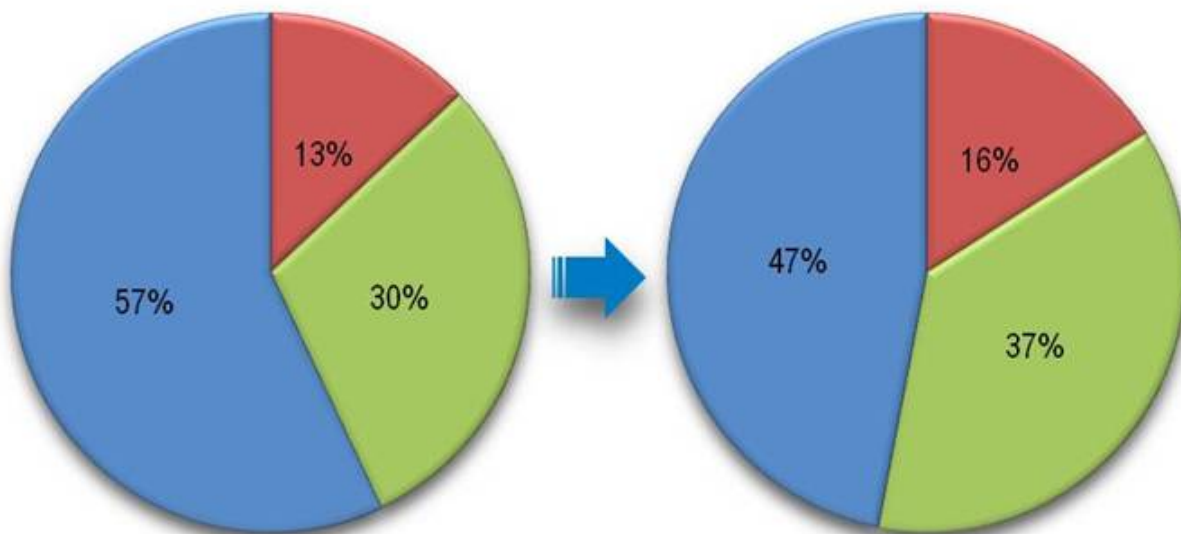

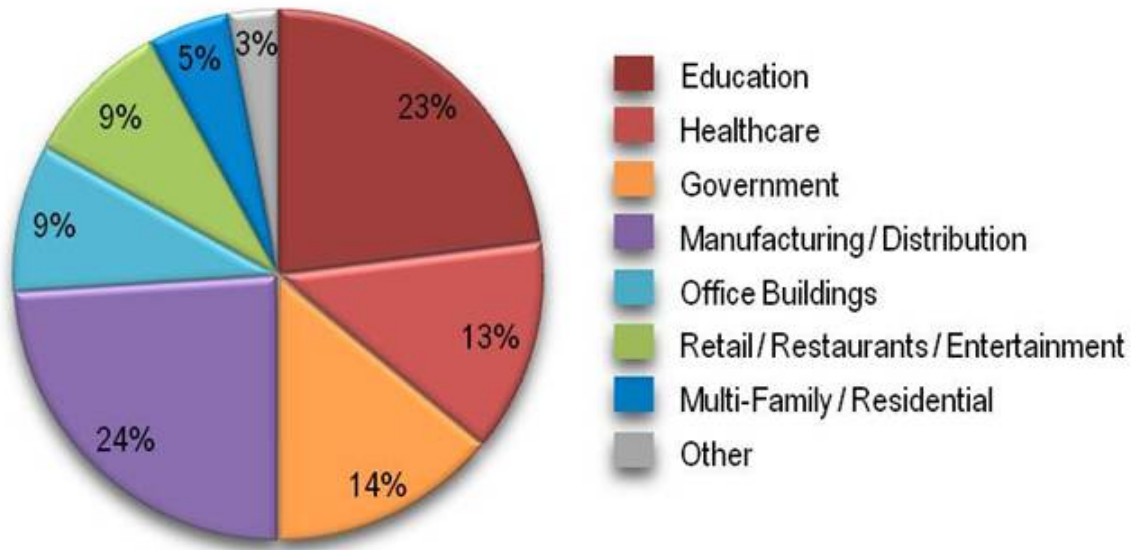

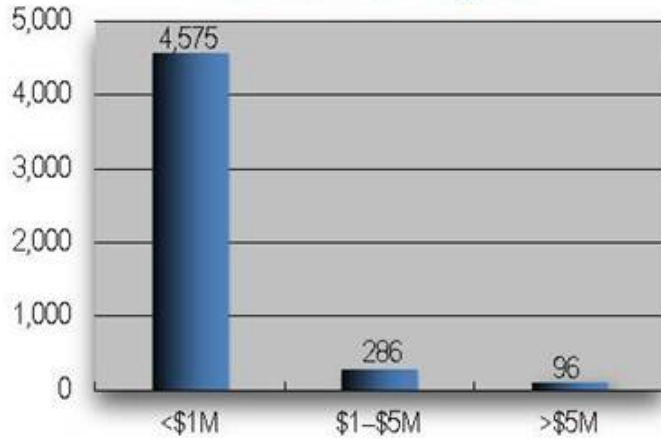
Revenue by Sector

September 2012 Year-to-Date Revenue

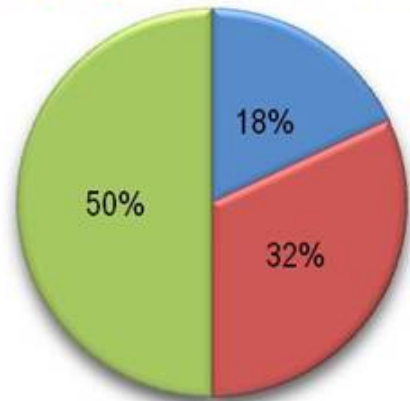

Aggregate Contract Value



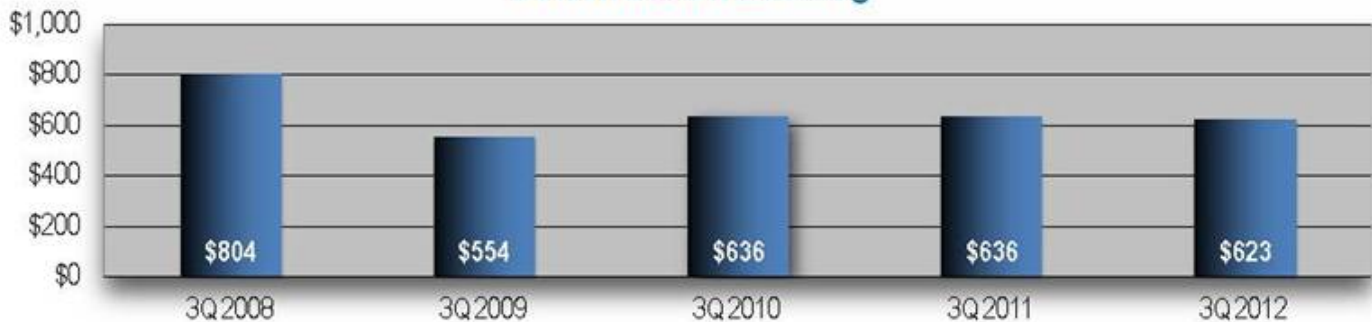

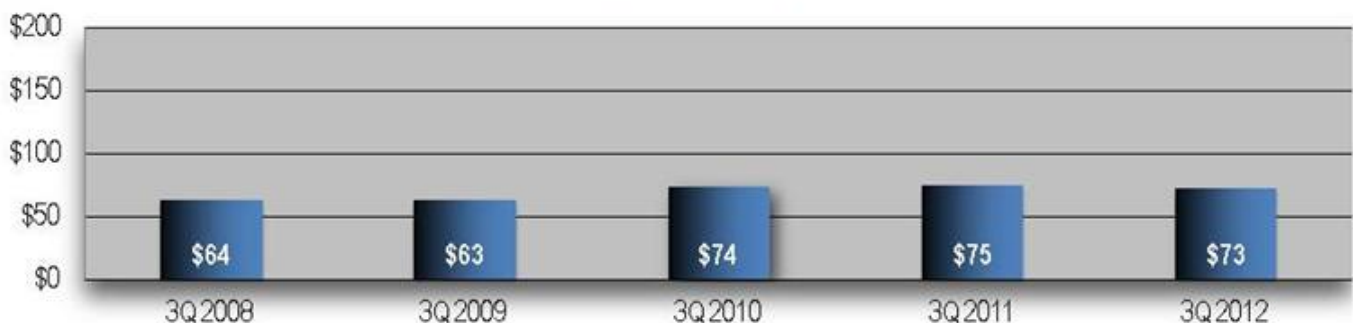

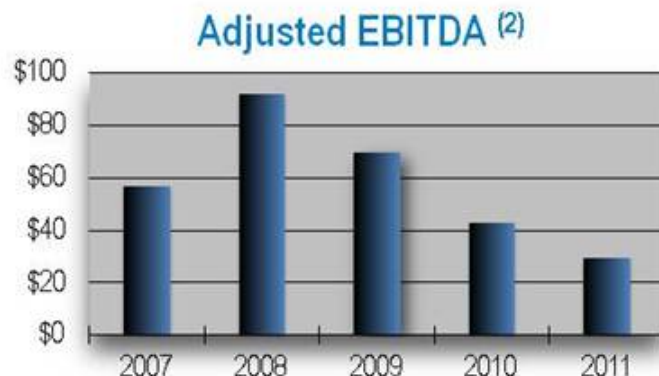
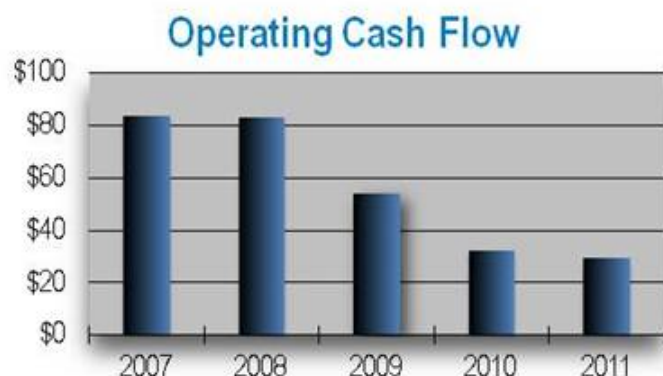
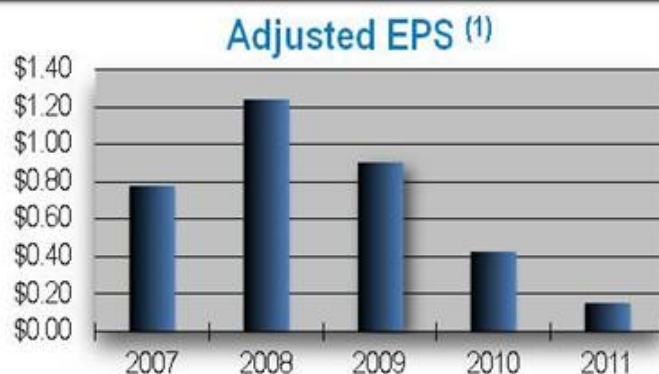
Construction Backlog

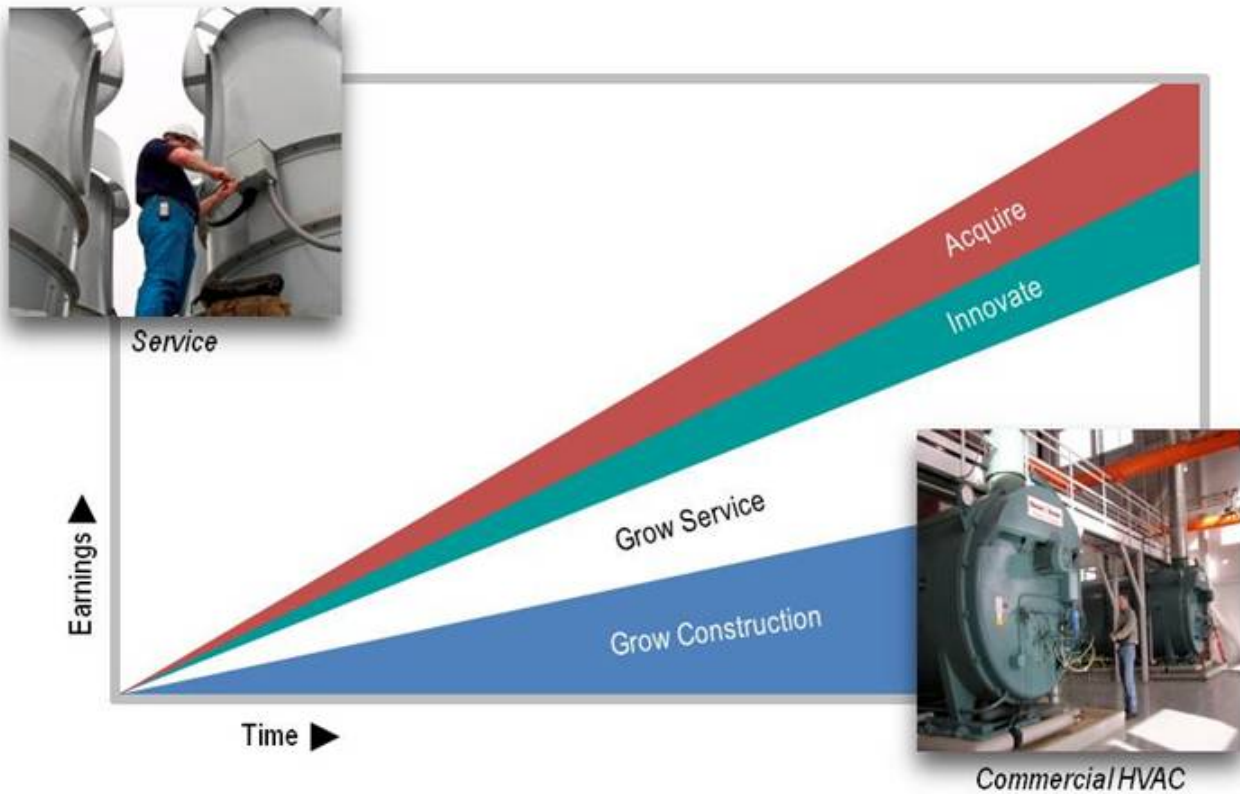

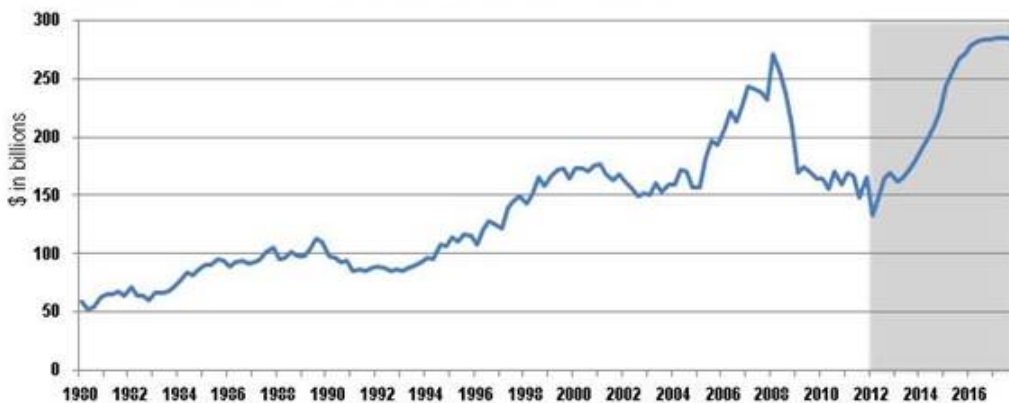

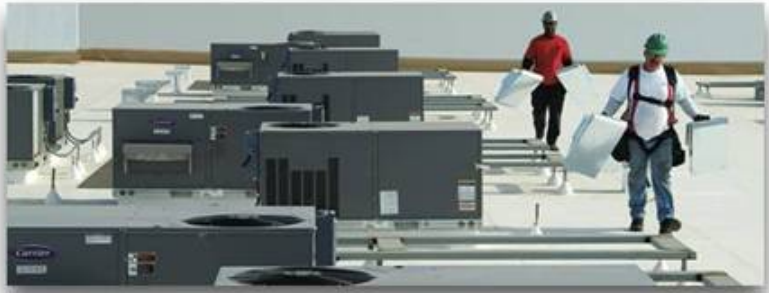
